



Notes:

Adjusted External Debt Level considers loans from subsidiaries and advances for capital increase as equity reserves and therefore not as actual debt, although these figures are currently booked within the long-term liabilities of the company.

2nd Question:

Who are the Mezzanine investors (Von wem wurde das Mezzaninkapital zur Verfügung gestellt)?

Mezzanine investors are 5 individuals holding the quotas (or fractions) of a SCP specifically established to fund the University Lighting project. SCP (Portuguese for "Sociedade por Cotas de Participacão") is a society of quotas, i.e. a silent partnership with special purpose within the limited company.

These investors belong to the extended network of SRN's shareholders (family and friends) and are allowed to stay anonym according to the terms of the SCP's contract.

Note: The amount of mezzanine capital gathered within the SCP for this project, which is called in Brazil "SCP's Social Fund", is R\$ 420.000 and it will be visible in the balance sheet of 2018. This class of liability is formally booked within the net worth of the company, although it should be considered as an external loan and should therefore be included in the adjusted debt level calculation for 2018.

3rd Question:


Explanation to negative results of 2017 (Erklärung zur negativen GuV 2017)

Attached is a detailed view of the Balance Sheet 2017, showing the break-down of the "Non-Current Liabilities". As already explained in question 1, loans from subsidiaries and advances for capital increase have to be considered as equity reserves.

In this context, the negative fiscal year result for 2017 (- R\$ 193.990,47) and consequently the resulting negative net worth of R\$ 187.990,47 at the end of the year are fully compensated by the total amount of capital (equity) reserves of R\$ 804.565,38 (sum of 124.565,38 and 680.000,00).

Other questions discussed in the phone call and pointed-out in the email of 25th April were already answered separately. If further explanation is needed, we are available at short notice.
